Minutes of the Sixteenth Inter Ministerial Board of Certification

The meeting was held on 13.09.2017 under the Chairmanship of Joint Secretary, Department of Industrial Policy and Promotion, Shri Rajiv Aggarwal. Representatives from the Department of Science and Technology, the Department of Biotechnology and Ministry of Electronics and Information Technology were present. Members of the IMB Secretariat were also present. The list of participants is enclosed (Annexure 1).

- 2. A list of ninety-one (91) entities incorporated before 01.04.2016 and thus, ineligible for tax benefits as per the Finance Act 2017, was presented to the Board. The Board was informed that these will continue to be recognized by DIPP as Startups.
- 3. The Board decided that in respect of Indian companies which are incorporated as subsidiary or joint venture of foreign companies and having technology transfer from the said foreign company will not be considered by IMB for tax benefits.
- 4. One hundred thirty-three (133) applications of entities incorporated after 01.04.2016 were presented to the Board for consideration of these startups for eligibility for tax benefits.
- 5. Of the above, two (02) applications were recommended by IMB for tax benefits. These are as follows:
