

Minutes of the Eighteenth Inter Ministerial Board of Certification

The meeting was held on 28.09.2017 under the Chairmanship of Joint Secretary, Department of Industrial Policy and Promotion, Shri Rajiv Aggarwal. Representatives from the Department of Biotechnology and Ministry of Electronics and Information Technology were present. Members of the IMB Secretariat were also present. The list of participants is enclosed (Annexure 1).

2. A list of sixty-two (62) entities incorporated before 01.04.2016 and thus, ineligible for tax benefits as per the Finance Act 2017, was presented to the Board. The Board was informed that these will continue to be recognized by DIPP as Startups.

3. Seventy-three (73) applications of entities incorporated after 01.04.2016 were presented to the Board for consideration of these startups for eligibility for tax benefits.

4. Of these, the Board considered and decided that seventy-two (72) startups are not recommended for Tax Benefits and will be provided observations for the same. Startups will be provided 30 days from the date of communication of the observations to reply to these observations or accept these observations as reasons for rejection.
